18-096 Actions from Previous Meeting

18-054.2 Sign for Jauncey Way ordered; Clerk to determine timescale for delivery – sign received and left at meeting with Cllr Bramma to put in place; Mrs Jauncey to be informed when it's done.

18-098 County Councillor's Report

Cllr Patmore reported that devolution is still on the agenda and that out of 24 authorities in Yorkshire 19 now behind One Yorkshire because they believe they will benefit financially. Those not wishing to join are Sheffield, Doncaster and Barnsley. Devolution will bring money in transport and highways, some in education. If it does come in it will not before county council election in 2.5 years.

VAS signs – did not go to exec this meeting because there was too much on the agenda, so delayed until next meeting. It will allow villages to purchase own signs with guidance. Phase 3 of broadband coming in soon (details will be announced in Spring). There is a social care £3m overspend predicted in N Yorks this year.

The revamped Northallerton prison site is to be called 'The Treadmills' and will have cinema and supermarkets, housing and a heritage centre. The Newby Whisk development that applied to be developed as an outward bound centre went to judicial review because there were points that the District Council did not do right initially so starting over, the application will go in November. Helperby and Brafferton Parish Councils are to join up.
